RESIDENT RESEARCH AWARDS
Available to Residents Only**

Section Resident Research Awards are given in recognition of outstanding scholarship and high scientific rigor. These awards, given by the four Sections of the Triological Society, have been named to honor notable teachers, surgeons and researchers in the field of otolaryngology-head and neck surgery. The Resident Research Awards are available to residents who submit an abstract by August 1st followed by submission of a manuscript to the Section in which they reside by September 1st. Award recipients are chosen by the Section Awards Committees, *based on the quality of the manuscripts received*. Residents chosen for these honors will present their papers as podium or poster presentations at the Combined Sections meeting in January, 2019. Additionally, resident awardees receive a monetary award and the training programs receive a Section Travel Award to help offset expenses incurred by the awardees to present their papers at the Combined Sections Meeting.

The requirements and timelines which must be met by residents are as follows:

- The resident must be a Triological Society Resident member in order to qualify for a Resident Research Award. Applications are available at www.triological.org and must be completed/submitted to the administrative office no later than September 1st.
- The resident must be in an accredited residency training program at time of submission and presentation.
- The resident must be the first author and presenter as listed on the abstract/manuscript and any subsequent submissions to *The Laryngoscope* or *Laryngoscope Investigative Otolaryngology*.
- The resident must indicate resident status and name of training program in the appropriate boxes on the online abstract submission form.
- The resident must submit the manuscript to the appropriate Section Vice President, based on eligibility by state (see list of Sections/States included)
- The resident awardee must register for and attend the Triological Society meeting (this criteria has been put into place due to the number of residents selected for poster presentations who do not register for and/or attend the meeting).

Manuscript Submission Information:

A cover letter must accompany the manuscripts, stating that you are submitting a manuscript in consideration for a Section Resident Research Award. The cover letter should contain all identifying information including names of authors, institutions, addresses, phone, fax, email, etc. Please indicate that you are the first author and the “corresponding” author. In addition to the cover letter, a copy of the abstract (submitted August 1st) should accompany the manuscript. **Submission of a manuscript to the Section Awards Committee does not fulfill the manuscript submission requirement to *The Laryngoscope* office (December 2018/January 2019 deadline) if your abstract is chosen for presentation at the meeting. Please review information for your appropriate Section below.**

Only residents in residency training programs in the states of NY, PA, NJ, CT, RI, MA, VT, NH, ME, and the Canadian provinces of PQ, ON, NS, NB and NF are eligible to receive awards from the Eastern Section.
